Mr. Tucker spoke about educating business owners on incentives for hiring prison releasees.

Communications Update:

The revised logo was presented to the Council. Ms. Daniels made motion to use the logo with the gun. The Council approved the motion by count of hands (9 yes - 2 no).

The revised poster image was presented to Council. Ms. Harris made a motion to accept poster with the added stats. The motion was seconded by Mr. Harrelson and Mr. Chambers. Mr. Thomas made an amendment to the motion, to hold off on accepting the poster until after the webpage is created so that the webpage information can be added. Motion was seconded by Ms. Harris.

Future Steps:

Community Input:

Ms. Pamela Chamberlin, a small business owner in health care, is excited to see that the City Commission and Chief DeLeo are working toward restoring Tallahassee. Ms. Chamberlin suggested the Council look into non-violence communication (NVC). She recommended the Council read <u>A Mindful Nation</u> written by Congressman Tim Ryan.

In response to the Communication presentation, Ms. Chamberlin would like to see a positive ad campaign. She voiced some concerns with posting markers as it may increase the number of violent crimes.

Chris Edwards, a Business Advocate for the City of Tallahassee, invited everyone to attend a celebration at Oliver Hill this evening at 6 p.m.
