## SUPPLEMENTAL REPORT

The attached statement of probable cause and arrest warrants for Aaron Lee Glee, Jr. for the offenses of Kidnapping and Felony Murder were reviewed and signed by the Honorable Judge Anthony Miller on June 14, 2020. The warrants were entered into FCIC and NCIC. The Orlando Police Department took Glee into custody for the aforementioned warrants on the same date. Although an arrest has been made, this investigation is ongoing and will remain disposed as Open/Active.
